20 – Contracts and agreements	
20.01	To approve the contract to be concluded with the organization VertCité (CRABE) of a duration of three years, ending on August 31, 2018, establishing the terms and conditions of the payment of financial contribution and to authorize an expense of \$318,545.14, taxes included, for the implementation of the Eco-community program activities in the Borough of Pierrefonds-Roxboro.
20.02	To authorize the renewal of the contract granted to Kelly Sani-Vac inc. for the cleaning of catch basins in the Borough of Pierrefonds-Roxboro for the period of May 1, 2015 to August 31, 2015, according to public tender number 13-12829, costs and conditions of its tender submitted on April 10, 2013, in the amount of \$46,007.24 including the taxes.
20.03	To authorize a total expense of \$88,350.86 taxes, contingencies and incidental costs included, for development work including the replacement of furniture such as waste bins, benches, bike racks and the addition of swing sets for children in various parks in the Borough of Pierrefonds-Roxboro. To grant to the only complying tenderer, Paysagiste Promovert inc., contract number ST-15-15 for the amount of its tender for a maximum amount of \$86,618.49, taxes included, in accordance with the tendering documents prepared for this contract.
20.04	That the Borough Council grants a professional service contract to the company Poirier Fontaine Architectes inc. at the amount of \$24,144.75, taxes included, from the budgetary surplus to produce a technical and functional program (TFP) in order to carry out the renovation and upgrade to standard of the Versailles pool and the Versailles park landscaping.
20.05	That the Borough Council grants a professional service contract to the company Expertise Sports Design LG at the amount of \$16,958.81, taxes included, from the budgetary surplus, to produce a technical and functional program (TFP) in order to complete the construction and landscaping of two synthetic soccer and Canadian football fields and a running track with related facilities.
20.06	That the Borough Council authorize the granting of a subsidy in the amount of \$10,000 to the community organization Les camps de jour Pierrefonds inc., as part of the "Programme montréalais de soutien à l'accompagnement en loisir pour les

personnes ayant des limitations fonctionnelles".

- **20.07** That the Borough Council authorize the granting of a subsidy in the amount of \$300 to the organization GUEPE, Groupe uni des éducateurs-naturalistes et professionnels en environnement.
- **20.08** That the Borough Council grant a financial contribution in the amount of \$300 to the Dorval-Jean XXIII High School in order to provide two \$150 scholarships to students who have achieved an exceptional academic performance.
