20.01	To grant to the lowest complying tenderer, La Compagnie Meloche inc., contract number ST-15-17 for the amount of its tender for an amount of \$132,815.70, taxes included, in accordance with the tendering documents prepared for this contract related to pavement works, plantation and related works on Jordi-Bonet and Laurent-Coderre Streets.
20.02	To authorize an additional expense of \$37 863,98 to the contract ST-13-07 granted to Groupe Mécano inc. for the repair of the Belvédère pumping station, in consequence, raising it from \$575,985.31 to \$613,849.29, taxes included.
