20 – Contracts and agreements

- **20.01** To grant contract 15-14128 to Kelly Sani-Vac inc. for the cleaning and camera inspection of sewer pipes including the transportation and disposal of waste, where required in the different pipes of the Borough of Pierrefonds-Roxboro for the year 2015-2016, in the amount of \$248,346, taxes included.
- 20.02 To grant contract 15-14672 to Lange Patenaude Équipement, Kubota Montréal for the supply of a narrow gauge utility tractor and of a removable Equipment (sidewalk cleaner with pressure) for the Borough of Pierrefonds-Roxboro, in the amount of \$91,341.89, taxes included.
- 20.03 To grant contract ST-15-02-02 to Les Excavations Gilbert Théorêt inc. for a new connection of water pipes, sanitary sewer pipes, storm pipes, abandonment of existing services and related work at 5221, 5225, 5229, 5233, 5237, 5241, 5245, 5249, 5253, 5257, 5261, 5265, 5269, 5273, 5277, 5281, 5285, 5289, 5293 et 5297, rue du Sureau, in the Borough of Pierrefonds-Roxboro Total expense of \$295,629.47 \$, taxes included.
