## 1. INTRODUCTION

The Strategic Plan for Sustainable Development (SPSD) for Pierrefonds-Roxboro is daring, reflecting the desire of the municipal administration to change the way in which it does things and to turn towards sustainable practices.

These changes in practices necessitate questioning the established order, and involve changing the internal management of the Borough, in practices associated with the land-use planning and with the offer of services to the population in terms of culture, leisure activities and entertainment.

Pierrefonds-Roxboro's Strategic Plan for Sustainable Development is divided into 103 actions, of which 37 have to do with the Borough's internal practices (corporate aspect) and 66 with municipal administration and Borough partners (local aspect).

While drawing up the Strategic Plan for Sustainable Development, the Borough's partners and employees formulated a vision for the future. This common vision for sustainable development in Pierrefonds-Roxboro for 2011-2030 is as follows:

"Pierrefonds-Roxboro will be a Montréal borough recognized for the quality of the services it offers its population while respecting the integrity of the natural environments. Pierrefonds-Roxboro will be able to meet the needs of people from all walks of life and from all age groups. The family will be at the heart of the Borough's concerns and will influence the choices made in the land-use planning, the facilities it provides and their distribution across the territory.

All Pierrefonds-Roxboro residents will have the opportunity to access Rivière des Prairies while respecting the fragility and the sensitivity of its natural environment. Neighbourhood parks and green spaces will be accessible to everyone.

By opting for continuity in the urban framework and by intensifying land use on its territory, the Borough is providing itself with the means to offer its population diversified, flexible services, efficient public transit services and beautiful surroundings.

Finally, Pierrefonds-Roxboro will be a Montréal borough in which proud, sensitive residents will participate in the protection and development of their living environment to provide future generations with a Pierrefonds-Roxboro where the urban environment and the natural areas coexist in harmony."



#### 1.1 METHODOLOGY

The 2012 Review allows the evolution of actions for the Borough's Strategic Plan for Sustainable Development to be monitored. When the Plan was drawn up, indicators were established for each action, in order to measure progress towards meeting the objectives for sustainable development. Throughout the year, data associated with these indicators were gathered by the Borough departments and then compiled by the president of the Follow-up Committee.

#### 1.2 FOLLOW-UP ON ACTIONS

The first action in the SPSD was to set up a committee to monitor the corporate and local actions in the Plan. Under the leadership of the Borough Director, the Follow-up Committee was formed by resolution of the Borough Council. Composed of the Mayor, the Borough Director (who is also the committee president), directors of the departments and certain employees, the committee met three times during 2012, in January, May and October.

At the first meeting, a person was selected to be responsible for each of the 2012 actions, and deadlines for the current year were established.

#### 1.3 PARTNERS COMMITTEE

A Partners Committee was also formed at the beginning of 2013 to ensure continuous communication with the Borough partners. The partners invited to become members of the committee are the same people as those who participated in drawing up the SPSD.

The Partners Committee will meet once a year, usually in January. The committee's objectives are as follows:

- Present the review for the previous year, identify the successes and the challenges;
- Discuss the review amongst members of the Partners Committee;
- From among the actions included in the SPSD, determine the priority actions for the current year;
- Identify methods and means for carrying out these actions;
- Identify, as needed, any actions that should be added to the SPSD;
- Invite the partners to share the actions and the successes in sustainable development for their respective organizations.



## 2. SUCCESSES FOR THE BOROUGH

The Borough of Pierrefonds-Roxboro has every reason to be proud of its achievements during the first year of implementation of the SPSD. The challenges that awaited the Borough were numerous, and changes in mentality, and in the way of doing things, led to the development of new thinking in regard to sustainable development.

The successes presented in this section are:

- Achievement of actions that were not included in the SPSD, but that are in line with its orientations and objectives;
- Achievement of actions that were included in the SPSD for future years, but as opportunities arose this year, were carried out in 2012.

Some success stories:

- Redevelopment of the parking area at Borough Hall
- Training drivers to drive ecologically (2014 action)
- Purchase of a Sprinter vehicle (2013 action)
- Construction of social housing Centre Bienvenue
- Pilot project: Permits electronic processing system
- Purchase of electrical equipment for the horticultural team
- Reduction, Recovery, Re-use and Recycling: the 4R's

## Redevelopment of the parking area at Borough Hall in terms of universal accessibility and sustainable development

The objectives of the redevelopment project were to rehabilitate the parking area at Borough Hall, re-design the western entrance to the building and improve the lighting, which was insufficient. This project was carried out in the fall of 2012, and was developed from the perspective of favouring universal accessibility while respecting the guidelines in the Strategic Plan for Sustainable Development for the Borough of Pierrefonds-Roxboro.

In terms of universal accessibility, the Borough of Pierrefonds-Roxboro is committed to making this a priority. Thus the re-design of the western entrance to Borough Hall includes the construction of an access ramp for persons with reduced mobility (2015 action in the SPSD).

Sustainable development: The parking area at Borough Hall was redeveloped in consideration of the objectives for reducing heat islands, reducing greenhouse gas emissions and better use of resources. What is more, with this redevelopment of the parking area, two actions in the SPSD that were planned for future years were achieved in 2012.

In short, here are the main features of the parking area redevelopment:

- Four double bike racks (eight bike parking spots) were added (2013 action);
- Installation of six "green" parking spaces with gratings and turf to favour natural absorption and help reduce heat islands;
- The Borough will become a partner in the Electric Circuit. Two parking spaces equipped with service points will be reserved for recharging electric vehicles (2013 action);
- Planting at the entrance to include deciduous shrubs, conifers, perennial flowers and grasses to replace annual flowers;
- Increase in the proportion of greenery and the number of trees by enlarging and expanding the central island with the planting of 22 trees and the addition of numerous planting beds filled with shrubs and grasses;
- Conversion of the existing lighting to energy efficient lighting (LED);
- Reduction in the length of parking spaces and in the width of access aisles to reduce mineral surfaces.

#### Action 10 C - Train our drivers to drive ecologically (2014 action)

Last fall, 38 Borough employees took a training course in ecological driving. The objectives of this training were to reduce GHG emissions, save on fuel costs, reduce vehicle wear and tear and improve workplace safety.

Fuel yield may vary by as much as 35% depending on the driving style. This training was meant for any employee who drives a light or medium vehicle within or around urban centres.

This interactive training included the following activities:

- Driving techniques that can reduce fuel costs, lessen harmful emissions and improve the safety of road transportation;
- Preventive maintenance and other practices that can improve vehicle Performance and reduce wear and tear;
- The effects of fuel and emissions on our environment;
- Safe driving practices that reduce the risk of accidents.

#### Purchase of a Sprinter vehicle (2013 action)

The true cost of a vehicle goes well beyond the sticker price. Fuel and maintenance costs and the vehicle's retained value can all affect costs in the long term.

The purchase of this new vehicle will allow the Borough to reduce GHG emissions produced by its fleet of vehicles and to reduce fuel costs. This vehicle saves 17 litres per 100 kilometres: the Sprinter consumes an average of 18 litres per 100 kilometres compared to a vehicle of a similar type, which consumes an average of 35 litres per 100 kilometres.

#### Social Housing Project - Centre Bienvenue

Centre Bienvenue is a community institution that offers services to a low-income adult clientele with mental health issues, on Montréal's West Island.

The Borough supported Centre Bienvenue in the adoption process for the construction of a new building intended to house a day centre on the ground floor and supervised social housing on the upper floors (20 apartments are planned). The building is currently under construction.

The development of supervised, affordable housing gives Centre Bienvenue the chance to offer the necessary tools for participants to be able to live independently in the future, without additional support. The objective for this social housing is to engage the target clientele in a process of social reintegration, while respecting their abilities, their strengths and their weaknesses. Residents will be able to depend on daily support from two caseworkers, specially trained to carry out the social re-integration project.

In addition to the project's social value, and the increased offer in affordable housing in the Borough, the architectural design of the Centre will raise the architectural quality of the sector.

## Redevelopment of the playground areas in Grier and À-Ma-Baie parks in accordance with the principles for universal access

The Borough has redeveloped the playgrounds in Grier and À-Ma-Baie parks. The work involved being major, the Borough opted for the complete overhaul of the playground areas. In conformity with the Ville de Montréal's municipal policy for universal access, the planning stage for the design included access to the equipment for all clienteles.









#### Introduction of a permits electronic processing system - pilot project

As part of the recent digitalization of construction drawings, the Borough will be proceeding with the installation of tools to allow construction files to be accessed, managed and documented electronically. The Borough now has thousands of drawings in digital format accessible from workstations. The next stage consists of purchasing computerized equipment to increase administrative efficiency and thus lessen the amount of documents that need to be printed.

A pilot project for electronic permits was introduced in 2012 with the aim of full implementation of the system in 2013. The main features of the system are as follows:

- Allows the Borough to complete the implementation of the digitalization project while avoiding the need to digitalize annotated drawings in the future;
- Improves the process for approval of drawings and saves a lot of time and manpower in their handling. They will be stamped by means of a PDF document, which will be inserted on each page;
- Provides a computerized drawing board to employees visiting construction sites allowing them to upload or download any documents required for inspections, to annotate any deficiency directly on site and also to insert photos. It is also possible to work via a WiFi connection, in real time. This avoids the need to print drawings that are already digital, shop drawings, assembly drawings, etc.



#### Streetlamps equipped with solar panels

The Borough is working on integrating the principles for sustainable development and healthy use of resources into the design of its projects.

With this aim in mind, 20 streetlamps with solar panels will be installed as part of the rehabilitation of a portion of boulevard de Pierrefonds between rue du Château-Pierrefonds and rue du Palomino.







#### Purchase of electrical equipment for the horticultural team

The horticultural team needed new work equipment. In line with the objectives of the SPSD, the choice was made to purchase battery-operated rather than gaspowered equipment. In addition to reducing GHG emissions associated with fossil fuels, electrical equipment is lighter, is easier to handle and the batteries are recyclable.





#### Reduction, Recovery, Recycling and Reuse: the 4R's

"The 4R's principle is the first principle of the Politique québécoise de gestion des matières résiduelles (Québec Residual Materials Management Policy). This policy is based on a hierarchy in the actions to be taken for the proper management of waste materials: Reduction at source, Recovery, Recycling and Reuse. Disposal of any end waste is obviously the last recourse." [Translation] Recyc-Québec

The Borough applied these principles when it carried out the following actions:

#### Installation of two tanks for windshield washer fluid

Two tanks for windshield washer fluid were installed in the Public Works yard for refilling the Borough's fleet of vehicles. This single act eliminates the consumption of 420 plastic containers per year.

#### Reconditioning of two snow plows instead of purchasing new ones

With the 4R's in mind, the Public Works Department decided to recondition two snow plows rather than purchasing new replacements. This saved a lot of money and also makes use of equipment that would have become obsolete over time.

# **3.** FOLLOW-UP ON LOCAL ACTIONS 2012

The section that follows presents each of the local actions in the SPSD that were planned to be carried out in 2012. When the SPSD was drawn up, budgetary considerations were not taken into account in the planning of actions. Thus during the first year of implementation, some actions proved to be too large in scope to be achieved in 2012.

Except in a few rare cases, the actions that were not accomplished this year have been postponed until next year.

The status of each action is indicated with the following symbols:



Action accomplished

Action partially accomplished

- Action underway
- Action postponed until 2013
- Action replaced by another action
- Action cancelled



The aim of doing a follow-up as part of the strategic planning process is to evaluate the implementation of the action plan, and measure progress in terms of the actions planned compared to the objectives set. The exercise is not static, and the implementation methods and the objectives may be revised - upwards to improve performance or downwards if the objectives planned at the outset prove to be unrealistic.

A large number of actions was deliberately planned for the first year to give a clear signal that implementation of the plan had begun. Thus 45 local actions were planned - an ambitious project given that the SPSD has only 66 local actions in total.

Of these 45 local actions for 2012, 26 are planned as on-going, in other words, they will recur each year of the SPSD, until 2015.

Just over half the actions (51%) were accomplished or partially accomplished by the end of 2012. 18% of the actions are still underway and should be completed by the beginning of 2013. It is therefore realistic to think that close to three-quarters of the actions will have been completed by the beginning of 2013.

One action was modified, but no local action was cancelled. 13 actions could not be implemented this year and they will begin in 2013 instead.

## Action 1 L – Set up an interactive platform to facilitate carpooling from the park-and-ride lot next to Borough Hall

On October 15, 2013, Monique Worth, Mayor of the Borough of Pierrefonds-Roxboro, presented the new electronic platform for carpooling among the Borough's residents and employees. An incentive parking lot is situated close to Borough Hall at the intersection of boulevards de Pierrefonds and Saint-Jean. The site of the incentive parking lot is strategic, considering the opening of the bus lane on boulevard Saint-Jean, which has been in operation since the summer of 2012.

To determine the demand for such a service, a survey was taken among Borough employees, which demonstrated that the presence of an organized offer was the greatest incentive for carpooling, and that 64.9% of respondents said they were interested by the setting up of a Web platform unique to Pierrefonds-Roxboro.

The Borough then called on the services of the company COVOITURAGEMONTREAL Inc., which is responsible for maintaining the electronic platform and to proceed with partnering users. The company also offers awareness workshops during special events.

The Borough of Pierrefonds-Roxboro is the first in Montréal to offer this service.





Action 9 L – Participate in the program to remove or replace conventional wood-burning appliances, funded by the Ministère de Développement durable, de l'Environnement, de la Faune et des Parcs and managed by Équiterre.

With the objective of improving air quality and reducing the use of wood heating (the main source of concentrations of fine particles in the air) in an urban setting, the Borough of Pierrefonds-Roxboro joined the "Feu vert" program to remove or replace wood-burning appliances, funded by the Ministère de Développement durable, de l'Environnement, de la Faune et des Parcs and managed by Équiterre.

Thus to encourage residents to part with their old appliances, the "Feu vert" program offers a financial incentive to anyone who removes or replaces these fixtures. It was announced that the program would continue until March 31, 2013 or until the budgetary envelope is used up.

The program was advertised several times on the Borough's Web site, on electronic billboards and in the magazine Life in Pierrefonds-Roxboro.

In 2012, 11 stoves and fireplaces were removed. As a permit is not required for updating the installations, the data are only partial because MDDEFP is not making the data public at this time.

#### 24 L – Continue to participate in Les Fleurons du Québec

In August 2011, the appraisers from Les Fleurons du Québec criss-crossed the Borough to assess the territory's horticultural decor once again.

Having received the classification *3 fleurons* in the 2008-2010 edition, the Borough was delighted to learn that the efforts made by residents, merchants and institutions to embellish the Borough had borne fruit. Thus the Borough obtained a *4 fleurons* result out of a possible 5 for the 2011-2013 edition, a testament to remarkable horticultural embellishment in a majority of the fields (municipal, residential, commercial and institutional). Thus we could say that Les Fleurons du Québec was very likely a source of motivation to encourage residents and the municipality to improve the horticultural and landscaped environment while respecting the principles of sustainable development.

#### 33 L – Prepare an action plan for urban safety

The Borough of Pierrefonds-Roxboro now has its own action plan for urban safety. Prepared in partnership with West Island Youth Action and the International Centre for the Prevention of Crime (ICPC), the action plan for urban safety was prepared by way of the following steps:

- Analysis and diagnosis of urban safety in Pierrefonds-Roxboro;
- Inventory of preventive actions to be taken on the Borough's territory;
- Setting up a working committee on safety in consultation with the Urban Safety Board;
- Drawing up of the new action plan by the ICPC in collaboration with Borough partners;
- Proposal for mobilization strategies for area partners;
- · Prioritization of actions to take to meet the needs identified;
- Proposal for strategies for the dissemination of the action plan.





30 L – Draw up a master plan of sports and recreational facilities, including projections for development in the Pierrefonds-Ouest sector

The master plan of cultural, sports and recreational facilities defines the priorities for actions in the future, so that they represent the challenges specific to the Pierrefonds-Ouest sector. The master plan included the planning of priority interventions over a 10-year period, based on an assessment of the current situation and an analysis of future needs.

Heedful of meeting the needs of its population in terms of services for sports and leisure, the Borough decided that this type of planning was required, considering the projected population increase resulting from the construction of the Pierrefonds-Ouest sector. The steps in preparing the plan were as follows:

- Inventory and evaluation of cultural, sports and recreational installations;
- · Identification of needs;
- Preparation of a vision for development;
- Public consultation;
- Preparation of the master plan.





#### 37 L – Promote urban agriculture in schoolyards

With a view to sustainable development, École Harfang-Des-Neiges, Éco-quartier Pierrefonds-Roxboro and Maison des jeunes À-Ma-Baie officially opened a **planter vegetable garden with water tanks**.

This vegetable garden is a joint project carried out with the participation of several partners, such as the CRE Montréal, the Commission scolaire Marguerite-Bourgeois and Kino Québec. Thanks to their contribution, fruits, vegetables and herbs were planted and harvested for educational purposes and to promote health and food safety.

Two rainwater collection barrels are connected directly to the building's gutters and downpipes to irrigate the planters. Using this system, 12,000 litres of water can be recuperated each year.

Éco-quartier is also associated with **École Lalande**, in the Roxboro neighbourhood, for gardening with 3 classes and their teachers in the vegetable garden behind Écoquartier. A facilitator was hired to accompany, bring awareness, inform and support the new participants in all the planting stages. During the summer vacation, the blue and green patrols, volunteers and Éco-quartier employees maintained the garden until the children returned to school.

**Éco-quartier** and the **Carrefour Cloverdale Multi-Ressources** also carried out several awareness activities for parents and children about balcony vegetable gardens. Éco-quartier was pleased to provide advice to parents by writing an article in its monthly newsletter about creating balcony planters.

#### 38 L – Participate in information campaigns about the use of drinking water

**Pierrefonds-Roxboro's Eco-quartier** distributed and sold 50 low-flow bathroom aerators, 170 rainwater barrels, 13 toilet fill cycle diverters, 11 shower hourglasses, 10 toilet tank bags and several other products. It is estimated that all these measures saved 3,073,028 litres of drinking water in 2012.

**Blue Patrol** activities continued again this year. For four weeks, the Blue Patrol - small team of two students - criss-crossed the Borough to raise awareness among Borough residents about efficient ways to save drinking water. Our patrols reached 1,201 residents, distributed 1,225 leaflets and visited 182 homes, public and private institutions, day camps and schools.

42 L – Raise residents' awareness of the ecological management of rainwater, and motivate them to use measures to save rainwater (e.g., rainwater barrels, replacing hard surfaces, rain gardens, ecological maintenance of ditches, disconnecting gutter downpipes)

On July 20, 2012, residents of Pierrefonds-Roxboro were invited to purchase a rainwater barrel at a reduced price of \$30. This project was made possible through funding from Fonds Éco IGA.

**Éco-quartier** distributed 140 barrels as part of this environmental project. These allowed residents to help save drinking water and to put rainwater to good use for gardening and lawn watering.

As the program was so successful, éco-quartier, with the support of Coca Cola, distributed 30 extra barrels at the reduced price. This meant an extra saving of 180,000 litres of water.

# 53 L – Encourage the creation of environmental companies and support them in their business development

Les Entreprises Environnementales Pierrefonds inc. (LEEP) has been operating an integrated management site for construction and demolition debris in the old quarry site since October 1999. The company also employs people from a social reinsertion program.

The company would have liked to add a sorting centre to its activities, by re-using and converting an existing building. The proposed building would however not have been in conformance with the National Building Code.

To encourage the company to pursue this and expand its activities, the Borough decided to support the company in a Request for different measure. The measure was approved and the project will be able to continue.

"A request for a different measure is an exception procedure since, as a general rule, the provisions set forth by the prevailing legislation must be applied.

The recourse to a different measure is not to be construed as a tolerance or a deviation procedure through which one may bypass complying with the Regulation. Any request which does not rest on valid reasons or meet with the purpose of the Regulation shall not be granted." – *Régie du Bâtiment du Québec*

#### The Ecological Gardening Day

The Borough, in partnership with Éco-quartier and the Société d'horticulture et d'écologie de Pierrefonds (SHEP) held its Ecological Gardening Day on June 2, 2012. Despite unfavourable weather, over 400 participants joined in the event. The day can be summarized as follows:

- 400 participants;
- 65 tons of compost;
- 5 tons of wood chips;
- 30 bags of asparagus and garlic bulbs (donated by the Pépinière de l'Ouest-del'Île);
- 40 packets of green and yellow beans (donated by Botanix-Cléroux et Frères);
- Clover seed (donated by la Ferme Québécoise);
- 1,000 perennial plants;
- 1,000 boxes of annual plants and flowers;
- 137 boxes of vegetables and herbs;
- Draw for 2 composters and 2 rainwater barrels;
- 100 tree seedlings (donated by Éco-quartier);
- Saving on drinking water with the Blue Patrol.

# 4. FOLLOW-UP ON CORPORATE ACTIONS FOR 2012

The first action in the corporate section of the SPSD was to set up a Follow-up Committee. The committee was set up and the Borough Director is acting as its chairperson. Three meetings were held during the first year, and a series of activities was implemented. In 2013, the mission of the Follow-up Committee will be modified slightly to add the organization of awareness activities for residents, businesses and employees. The setting up of a structure to exchange information meant that most of the corporate actions that had been planned for 2012 were accomplished.

# 21 C – Develop a Guide on Eco-Responsible Practices for Borough employees

One of the corporate actions in the SPSD was to develop a guide to ecoresponsible practices for use by Borough employees. Instead, the Borough opted for a more participatory approach to replace the production of a guide.

First, an online survey was taken with the aim of understanding **why** employees have certain *bad habits*, in order to decide on an adequate response.

One out of every four employees completed the survey, and the results showed that a large number of them are already aware of eco-responsible practices.

The survey also identified certain ways to improve the habits of employees:

- Print fewer e-mails and improve document management (electronic documents instead of paper);
- Increase recycling in the Borough's offices;
- Place recycling containers in prominent locations (1 per floor);
- Make sure that computers are configured to print on both sides of the paper automatically;
- Reuse paper printed on one side only;
- etc.

To improve the habits of its employees, the Borough has chosen to hold several awareness activities for its employees in the years to come. The Follow-up Committee will organize these activities.
