

## Public review of the 2022 budget and the 2022-2031 ten-year capital works program of Ville de Montréal, its paramunicipal bodies and the STM

### Virtual public meetings

The committee on finance and administration invites you to take part in a public review of the 2022 operating budget and the 2022-2031 ten-year capital works program of Ville de Montréal, its paramunicipal bodies and the Société de transport de Montréal (STM).

The public review will be held from **January 6 to January 14, 2022**. Given the public health situation, the public sessions will be held by videoconference and livestreamed at [ville.montreal.qc.ca/etudebudget2022](http://ville.montreal.qc.ca/etudebudget2022). We also invite you to consult the presentations schedule of the municipal departments and paramunicipal organizations.

The public review of the budget and ten-year capital works program will be conducted in two parts. During the first part, Montrealers will have an opportunity to read the 2022 budgets and the 2022-2031 ten-year capital works program of the municipal departments, paramunicipal bodies and the STM which will be presented to the committee, and to submit their questions and comments. The second part will be devoted to the development and adoption of the committee's recommendations.

#### PRESENTATION BY MUNICIPAL DEPARTMENTS, PARAMUNICIPAL BODIES AND THE STM

During the public review, the municipal departments, paramunicipal bodies and the STM will present their 2022 operating budget and their 2022-2031 ten-year capital works program, as the case may be.

#### QUESTION AND COMMENT PERIOD

After each presentation, and following the tabling of the budgets of the paramunicipal organizations and bodies, time will be set aside for questions and comments from the public and then from committee members, which city representatives will answer.

The form will be accessible **30 minutes before the start of the session** and will remain available until the start of the public question and comment period.
