

## On the Way to School: Safety and Active Mobility

The [Commission sur le transport et les travaux publics](#) (the committee) has been mandated (CE23 0406) to hold a public consultation on safety of school zones. The committee would like to consult Montrealers, especially parents and crossing guards, on safety measures for primary and secondary school zones and active mobility.

### Step 1 – Obtain information

The consultation document will be presented during a **public information session**.
