

(loss of habitat)**




Bioclimatic Region of Montreal


Map of Threatened Species

City of Montreal Survey (2002)

80% people: *It is extremely important to conserve our natural milieu*



66% people: *Not enough is being preserved.*

Recommendations: Enlarge l'Anse-à-l'Orme park



proposed in 2006

- proximity to 4 million people
- park size necessary for ecosystems requiring large areas to thrive

2.3 Mettre en Valeur les Territoires d'intérêt Les Territoires d'intérêt Écologique

Recommendations: Raise the objective of preservation of natural spaces beyond 8%.

Persons living in proximity to natural spaces (Brief, pp. 14-26) have **better mental and physical health**, affected less often by strokes and heart disease, **less risk of fatal diseases**.



Natural spaces **ignite our children's curiosity to learn**, improves their capacity to focus, enhances their cognitive abilities. (Brief, p.27)



2.3 Mettre en Valeur les Territoires d'intérêt Les Territoires d'intérêt Écologique

Recommendations: Preserve small areas of natural spaces throughout the Island.




“Even small parks in the heart of our cities can protect us from strokes and heart disease, perhaps by cutting stress or boosting exercise.”

Many citizens do not have the means to leave the city to benefit from natural spaces.

2.3 Mettre en Valeur les Territoires d'intérêt Les Territoires d'intérêt Écologique

Recommendation: **Preserve the entire 57 hectares of Meadowbrook and make it an Urban Nature Park.**



Could provide **natural space** for residential developments on the vast areas to the west of Meadowbrook, in Lachine, being cleared of their industrial past. **Parks help narrow health gap between rich, poor**, studies show. (Brief, p. 20)

Remediation of Brownfields



- Up to 10% of the Island are brownfields.*
- In 2010 in Nagoya, Montreal committed itself that “By 2020,...restoration of at least 15 per cent of degraded ecosystems, (Brief, p. 12)

*Montreal City Contract, 2003-2007, January 29, 2003, p. 40, “Montreal currently contains an estimated 4800 hectares of contaminated land.” “...Between 1999 and 2002, fully 170 hectares of land were decontaminated...”

Remediation of Brownfields

Recommendations:

1. Re-new the ClimatSol Program



2. Create a distinct municipal program with budget and goals

Les Territoires d'intérêt Écologique

Recommendations: 17% must remain the target

Reasons:

- We have no idea what Montreal can achieve, 10%, 15% ?
