ISSUES AND IMPACT REGARDING A BAN ON SINGLE-USE PLASTIC BAGS

The committee will hold public consultation meetings on the issues and impact that a ban on single-use plastic bags may hold for the retail sector on the territory of Ville de Montréal. It will examine the environmental, social and economic impact of an eventual ban in view of what has happened in other cities and states that have banned plastic bags. The committee will also evaluate the impact of the implementation of regulations for retailers and bag manufacturers and try to find alternatives to single-use plastic bags.

The public consultation will be held in three parts. The first, an information session, will be intended for the presentation of the project by the Service de l'environnement, as well as for public questions. The second part will be the hearing of opinions and briefs. The adoption of recommendations by the committee will be the object of the third part.
