PUBLIC CONSULTATION

**Montréal, Cultural Metropolis  
Draft 2017-2022 Cultural Development Policy**

The Commission sur la culture, le patrimoine et les sports invites organizations, cultural partners and citizens to take part in a public consultation on a draft 2017-2022 cultural development policy titled **Savoir conjuguer la créativité et l'expérience culturelle citoyenne à l'ère du numérique**.

This draft policy presents an integrated view on culture. It aims at creating and promoting, in a strategic and progressive manner, an environment that encourages the creation, dissemination, exportation and appropriation of various cultural expressions for and by citizens.

The policy places the citizen at the heart of the action. It encourages participation and commitment by offering access to a wide variety of experiences in every part of the city. It is based on the complementarity between technological innovation and the cultural experiences of citizens.

The objective of the public consultation on the draft policy is to adopt, in June 2017, a final version that will bring together the city's driving forces behind Montréal, Cultural Metropolis. The public consultation meetings will be held as follows:
