### *Impacts of the Royalmount project – Hearing of briefs*

The *Commission sur le développement économique et urbain et l'habitation* wishes to inform citizens that following the public presentation held on November 27, public meetings have been added in order to allow the committee to hear the public's opinion on the impacts of the Royalmount project, a large shopping centre including tourist accommodation and entertainment infrastructures, located at the intersection of Autoroute 15 and Autoroute 40, in the industrial sector of the City of Mount Royal. In addition to these components, the developer plans to add a residential section, which would require a modification to the Montréal urban agglomeration land use and development plan.

Some 50 briefs and opinions will be tabled, of which more than 30 will be presented to committee members during the five videocast public meetings to be held as follows:
