#### CONDUCT OF MEETINGS

### (1) Business unit presentations

Business units and paramunicipal bodies will take turns presenting their 2021 operating budget and 2021-2030 ten-year capital works program. Following the presentations, there will be time set aside for the committee to read questions and comments from the public, as well as time for the city's resource persons to respond.

Anyone who wishes to ask business units a question is invited to fill out the online form (in French) available today at <a href="ville.montreal.qc.ca/etudebudget2021">ville.montreal.qc.ca/etudebudget2021</a>. The committee chair will read the questions during the public question period, and the questions will then be answered by the departments concerned. You must complete the form for each department you would like to question. One question per person will be read initially. When time permits, a maximum of two questions per person will be read.

### (2) Closed-door sessions to develop recommendations

The committee will meet after the business units' presentations to develop its recommendations during working sessions held behind closed doors.

#### (3) Session to adopt recommendations

The committee will adopt its recommendations during a public session. This public meeting will be held by videoconference on December 7, at 2 p.m. The session will be livestreamed at <a href="wille.montreal.qc.ca/etudebudget2021">wille.montreal.qc.ca/etudebudget2021</a>. The committee's draft recommendations will also be posted to the same webpage for viewing at 9 a.m. on the same day.

If you would like to ask a question during the session to adopt recommendations, an online form (in French) will be available between 9 a.m. and noon on the day of the meeting on the consultation webpage at (ville.montreal.qc.ca/etudebudget2021).

The committee chair will read the questions during the public question period, and the questions will then be answered by the committee. One question per person will be read initially. If time permits, a maximum of two questions per person will be read.
