

# Eliminating food waste in Montréal: Virtual public consultation

The <u>Commission permanente sur l'eau</u>, <u>l'environnement</u>, <u>le développement durable et les grands parcs</u> (the committee) has been mandated to hold a public consultation on the elimination of food waste.

A group of citizens filed an application for the consultation under the right of initiative, specifically "to motivate the city to introduce measures based on best practices (regulatory changes, action plan, incentives, etc.), in an effort to eliminate food waste and the destruction of edible food by businesses, institutions and industry".

The committee invites interested parties to participate in the consultation, which will essentially be held by videoconference, in accordance with government guidelines in effect during the pandemic.

#### STEP 1 - OBTAIN INFORMATION

The consultation **documents** (in French) are available on the city's website at <u>ville.montreal.qc.ca/gaspillagealimentaire</u>. You can also request to receive the documents by mail, by calling 514-872-3000.

The request of the representatives of the group that filed the petition under the right of initiative, as well as the consultation documents, will be presented during a **virtual information session**, which will be held as follows:

DATE AND TIME: THURSDAY, DECEMBER 3, 2020, AT 7 P.M.

By videoconference

The link to view the **webcast of the session** will be available on the day of the meeting at <u>ville.montreal.qc.ca/gaspillagealimentaire</u>.

Following the presentations, time will be set aside for the reading of questions and comments from the public, as well as for responses from the city's resource persons, representatives of the group of petitioners and committee members, if any.
