### ENTRY FORM

#### **1- Contest – "Si j'étais maire"**

Participants must present their electoral platform by creating a "home-made" video clip using a webcam, still camera, portable telephone, or other photography device. This clip must last between 30 seconds and 1 min. 30 seconds, during which participants must present their electoral platforms by broaching at least two of the following topics:

- Environment, sustainable development, and urban planning;
- Governance and civic duty;
- Information (communication between the city and its citizens);
- Fight against poverty, social marginalization;
- Academic perseverance, employment, and entrepreneurialism;
- Sports, recreation, and culture.

#### **2- Eligibility criteria**

To enter the contest, participants must satisfy the following criteria:

- Must be between the ages of 18 and 30;
- Must live in one of the 19 boroughs comprising Ville de Montréal;
- Must not be elected as a municipal councillor and must not be running in the November 2013 municipal election.

Proof of age and residency (for example photocopy of a driver's license) may be requested.

#### **3- Date and time set as the bid submission deadline**

The registration form and video clip must be sent no later than May 20, 2013 at 9 AM, using a free application such as "[We transfer](#)", "[Dropbox](#)" or any other application intended for file transfer purposes. The link must be sent by e-mail to [cjm@ville.montreal.qc.ca](mailto:cjm@ville.montreal.qc.ca) with "Si j'étais maire" contest indicated in the subject line.
