

## PUBLIC REVIEW OF THE 2023 BUDGET AND THE 2023-2032 TEN-YEAR CAPITAL WORKS PROGRAM OF VILLE DE MONTRÉAL. ITS PARAMUNICIPAL BODIES AND THE STM

#### **Public meetings**

The Commission sur les finances et l'administration (committee) invites you to take part in a public review of the 2023 operating budget and the 2023-2032 ten-year capital works program of Ville de Montréal (the city), its paramunicipal bodies and the Société de transport de Montréal (STM).

The public review will take place from December 1 to 8, 2022. The public sessions will be held at city hall and livestreamed at ville.montreal.gc.ca/etudebudget2023.

The public review of the budget and the 10-year capital works program will be conducted in two parts. The first part is an opportunity for Montrealers to review the 2023 budgets and the 2023-2032 10-year capital works program of municipal departments and the STM and to submit their questions and comments. During the second part, the committee will develop and adopt its recommendations.

### CONDUCT OF THE PUBLIC REVIEW OF THE 2023 BUDGET AND THE 2023-2032 TEN-YEAR CAPITAL WORKS PROGRAM

#### PRESENTATION OF MUNICIPAL DEPARTMENTS, PARAMUNICIPAL BODIES AND THE STM

During the public review, municipal departments, paramunicipal bodies and the STM will take turns presenting their 2023 operating budget and, as the case may be, their 2023-2032 ten-year capital works program.

#### QUESTION AND COMMENT PERIOD

After each presentation, and following the tabling of the budgets of the paramunicipal organizations and bodies, time will be reserved for questions and comments from the public and then for questions and comments from committee members, to which city representatives will respond.

#### Individuals who would like to ask a question or submit a comment can do so in two ways:

1- by going to city hall (155, rue Notre-Dame Est) to attend the sessions of interest to them;

2- by submitting their question or comment using the online form (in French) available at ville.montreal.qc.ca/etudebudget2023.

The form will be accessible before the start of each session and remain open until the beginning of the public question and comment period.

#### PUBLIC MEETING TO ADOPT THE RECOMMENDATIONS

After the presentations of the municipal departments and bodies, the committee will meet during working sessions behind closed doors to develop the recommendations.

Afterwards, the committee will present and adopt its recommendations during a public virtual meeting to be held as follows:
