20.01	To grant contract 14-13887 to Les Équipements Colpron inc. for the rental of equipment without operator of three (3) tractors and salt/sand spreaders for the snow clearing of the sidewalks in the Borough of Pierrefonds-Roxboro at a total cost of \$256,560.96, taxes included, from the operating budget .
20.02	To grant contract 14-13859 to Pavages D'Amour inc., for the removal of snow in the Borough of Pierrefonds-Roxboro, sectors 1 and 2, for the period of November 1, 2014 to April 30,2019, at a total cost of \$1,612,742.30, taxes included
