20 – Contracts and agreements

- 20.01 To grant contract ST-15-13 to La Compagnie Meloche inc. for road repair, drainage work, asphalt paving, curb and related work on rues Saraguay Ouest (between Saraguay Est and the north end), Edison, Desjardins (between Lakeview and 13261, rue Desjardins), Sauriol, New Castle and Perron (between des Arbres and Pavillon) in the Borough of Pierrefonds-Roxboro Total expense of \$2,699,783.04, taxes included (contract: \$2,546,965.13 + incidental costs : \$152,817.91)
- 20.02 To grant contract ST-15-08 to Les entreprises de construction Ventec inc. for development work including the construction of a dog run and the construction of paved trails, supply and installation of furniture and playground Equipment, rehabilitation of a baseball field, plantation work and related work at Brook Park and Cérès Park in the Borough of Pierrefonds-Roxboro Total expense of \$623,790.22, taxes included (contract \$611,559.04 + incidental costs \$12,231.18)
- **20.03** To grant contract ST-15-11 to Les Entrepreneurs Bucaro for development work including the construction of a water play area including the concrete surface construction, paved trail, concrete paved surface, installation of water play modules, power system, and pluvial and electric connection and the construction of a paved parking, supply and installation of furniture plantation work and related work in the du Boisé Paark of Roxboro Total expense of \$1,333,998.20, taxes included (contract \$1,307,841.37 + incidental costs \$26,156.83)
- **20.04** To grant contract SP-2015-01 to Les Services EXP inc. for Professional services for the supervision of road infrastructure work for the year 2015 in the Borough of Pierrefonds-Roxboro, for a total amount of \$282,413.09 (taxes included)
- 20.05 To agree to the lease for the free of charge rent of Chalet À-Ma-Baie premises to La Maison des Jeunes À-Ma-Baie inc. from the period of June 1, 2015 to May 31, 2016, and to authorize Mr.Jean-Marc L'Abbé, Director, Culture, Sports, Leisure and Social Development to sign the said lease.

- 20.06 To grant a subsidy of \$1,000 to the Commission sportive du Lac Saint-Louis for its 2014-2015 Financial campaign, from the operating budget

- **40.01** Adoption of by-law CA29 0040-20 modifying by-law CA290040 in order to remove lots 1 349 410 and 1 349 417 (17089 17091, rue Saint-Denis) from the commercial C-3-216 zone, to integrate them to the residential H1-3-215 zone, to authorize in same zone the use two-family dwelling and three-family dwelling "H2" of detached structure and to specify for this type of use the implementation standards to the specifications chart of the said residential zone
