20.01	Grant an annual subsidy in the amount of \$300 from the 2017 operating budget to the community organization Volunteer West Island.
20.02	Grant an annual subsidy of \$300 from the 2017 operating budget to the Centre d'aide et de lutte contre les agressions à caractère sexuel (CALACS) de l'Ouest-de-l'Île for the year 2017.
20.03	Grant a subsidy of \$1,322.21 from the 2017 operating budget to the community organization Action Jeunesse de l'Ouest-de-l'Île within the launching of a benefit concert to its profit which will be held on April 8, 2017. Authorize Mrs. Louise Zampini, head of division, Culture, Libraries Social Development, to sign the agreement on behalf of the City.

Authorize Mrs. Louise Zampini, head of division, Culture, Libraries and Social Development, to sign the agreement on behalf of the City.
20.05	Authorize the renewal for the year 2017 of the agreement with the Association aquatique Valleycrest, authorize Mrs. Francyne Gervais, Acting director of Culture, Sports, Leisure and Social development to sign the agreement and grant a financial contribution of \$94,219 from the operating budget.
