- **12.01** Contract ST-18-03 Propose to the city council, in accordance with Section 85 of the Charter of Ville de Montréal, the management by the Borough of the realization of the works for the road, curbs, sidewalks and drainage works as well as related works on boulevard Gouin Ouest, 2^e Avenue Nord, 3^e Rue and the beginning of 3^e Avenue Nord and 4^e Rue: construction of a sanitary sewer pipes on boulevard Gouin Ouest between 2^e and 3^e Avenue, reconstruction of water pipes, sanitary sewer pipes and storm sewer pipes in 2^e Avenue Nord and reconstruction of water pipes, of sanitary sewer pipes on 3^e Rue in the Borough of Pierrefonds-Roxboro.
- **12.02** Contract ST-19-04 Propose to the city council, in accordance with Section 85 of the Charter of Ville de Montréal, the management by the Borough of the realization of the works for the restoration of sanitary sewer pipes, road, curbs and drainage works on rues Belleville, Racine, Kent, Delray, Grey and Fox in the Borough of Pierrefonds-Roxboro.

- **20.01** Authorize the appropriation of a sum of \$43,000, from the budgetary surplus for the granting of a subsidy with agreement to the community organization Action Jeunesse de l'Ouest-de-l'Île in order to finance the coordinator position for the "Open Gym" activities for the 2019-2020 school year. Authorize Mrs. Louise Zampini, head of division, Culture, Libraries Social Development, to sign the agreement on behalf of the City.
- **20.02** Grant a subsidy in the amount of \$1,322.21 to the the community organization Action Jeunesse de l'Ouest-de-l'Île within the launching of a benefit concert to its profit which will be held on April 13, 2019. Authorize Mrs. Louise Zampini, head of division, Culture, Libraries Social Development, to sign the agreement on behalf of the City.
- **20.03** Grant an additional maximum expense of \$1,501.57, taxes included, in the contingencies budget of contract SP-2017-04 granted to the firm Groupe Axor inc. for professional services in civil engineering, traffic specialty, for the design and monitoring of the traffic flow maintenance during works on boulevard Gouin Ouest between 1^{re} Avenue Nord and 3^e Avenue Nord in the Borough of Pierrefonds-Roxboro, bringing the total contract amount from \$24,460.93, taxes included to \$25,962.50, taxes included.
