20.01	Grant a subsidy in the amount of \$2,705.37 from the 2019 operating budget to the Association de natation Briarwood to cover the costs related to urgent repairs incurred by the organization during the preparations for the opening of the Briarwood swimming pool for the 2019 season.
20.02	Grant a subsidy in the amount of \$300 from the 2019 operating budget to the West Island Mission organization for its 2019 Christmas Baskets program which will take place on December 14, 2019.
20.03	Grant an annual subsidy in the amount of \$300 from the 2019 operating budget to the community organization Volunteer West Island.
20.04	Grant a subsidy with agreement in the amount of \$1,700 from the 2019 operating budget to the community organization Club Roxboro 60 Plus for the year 2019 and authorize Mrs. Louise Zampini, head of division, Culture, Libraries and Social Development, to sign agreement on behalf of the City.
20.05	Approve the agreement between Ville de Montréal and the community organization Action Jeunesse de l'Ouest-de-l'Île for the consolidation of Programme montréalais de soutien à l'action citoyenne en sécurité urbaine and grant a subsidy in the amount of \$12,500 from the Central City for the year 2019-2020. Authorize Mrs. Louise Zampini, head of division, Culture, Libraries Social Development, to sign agreement on behalf of the City.

- 20.06 Grant a subsidy in the amount of \$14,733 paid by the Central City for the period from November 1, 2019 to October 31, 2020 to Cloverdale Multi-Ressource inc. which acts as a trustee for the collective mobilization initiative as part of the Initiative montréalaise de soutien au développement social local and authorize Mrs. Louise Zampini, head of division, Culture, Libraries and Social Development, to sign said agreement on behalf of the City.
- 20.07 Authorize as part of contract ST-19-18, a total expense of \$644,111.57, to wit \$565,010.15, taxes included for the contract, \$56,501.02, taxes included for the contingencies and \$22,600.41, taxes included for incidental costs for drainage works, landscaping and related works at various addresses in the Borough of Pierrefonds-Roxboro. That the council grant the contract to the second compliant tender Ali excavation inc. for the amount of its tender, namely \$565,010.15, taxes included.
