20 – Contracts and agreements

- 20.01 Approve the local agreement between the Marguerite-Bourgeoys school board (CSMB) and the Direction, Culture, Sports, Leisure and Social Development (DCSLDS), intended to regulate the sharing of facilities as well as school and municipal equipment and mandate Mr. Dominique Jacob, director of the Borough of Pierrefonds-Roxboro, to sign the agreement.
- **20.02** Authorize the Direction of Culture, Sports, Leisure and Social Development to apply for funds from the Programme des installations sportives extérieures (PISE) for the addition of a beach volleyball at Alexander Park, the repair of the bocce and petanque fields at Grier Park and the addition of bicycles racks at Grier Park, authorize the Borough's adherence to the Programme des installations sportives extérieures 2019-2021 and confirm the Borough's participation to the project funding
- **20.03** Grant a financial contribution in the amount of \$4,500 from the 2020 operating budget to VertCité for the management of the washable diapers grants program for the territory of the Borough of Pierrefonds-Roxboro and authorize Mrs. Louise Zampini, division head, Culture, Libraries and Social development, to sign the agreement on behalf of the City.
