- **20.01** Grant subsidies totalizing \$92,625.15 to the following four organizations within the "Entente administrative sur la gestion du Fonds québécois d'initiatives sociales Alliances pour la solidarité (Ville-MTESS 2018-2023)":
  - CIMOI Bris d'isolement et initiation à l'informatique pour femmes immigrantes 20 877 \$
  - Cloverdale Multi-Ressources inc Amusons-nous à la joujouthèque LUDI 9 998,90 \$
  - Carrefour des 6-12 ans de Pierrefonds-est Accompagne-moi dans mes arts 30 236 \$
  - AJOI Travail de rue / milieu Pierrefonds-Roxboro 31 513 \$

Approve the draft agreements between Ville de Montréal and each organization establishing the terms and conditions for payment of these subsidies and authorize Mrs. Louise Zampini, division head, Culture, Libraries and Social Development, to sign agreements on behalf of the Borough.

- **20.02** Accept the Municipal Council's offer, in accordance with Section 85 of the Charter of Ville de Montréal, to mandate the Direction du service de la culture to enter into fixed-price agreement for the broadcast royalty management with the organization ENTANDEM, the SOCAN and RÉ:SONNE representative, for the period from January 1, 2019 to December 31, 2023, for the billing, the collection and reception of the licence fees payable for the public performance of the sound recordings published in the RÉ:SONNE repertoire and/or musical works from the SOCAN repertoire during activities or events in the Pierrefonds-Roxboro Borough. Authorize the payment of an amount of \$4,794.46, taxes included, for the years 2019 and 2020 and the following payments for the subsequent years: 2021: \$2,427.89, 2022: \$2,458.25 and 2023: \$2,488.97.
- **20.03** Grant subsidies for a total amount of \$70,000 distributed as follows: \$45,000 to the community organization Action Jeunesse de l'Ouest-de-l'Île for the Open Gyms Pierrefonds project and \$25,000 to the organization Projet de prévention des toxicomanies : Cumulus, in the context of the Programme de prévention de la violence commise et subie chez les jeunes 2020. - **40.02** Adoption of by-law CA29 0040-42 modifying zoning by-law CA29 0040 in order to bring the following modifications: addition of article 65.1 regarding seasonal kiosks for the outdoor sale of fruits and vegetables and modification of article 311 in order to add "Sandwich" panels as temporary sign authorized.
