- **20.01** Offer to the Municipal Council, in accordance with second paragraph of Section 85 of the Charter of Ville de Montréal, métropole du Québec (R.L.R.Q., c. C-11.4), that the Borough of Pierrefonds-Roxboro take charge of the design, coordination and execution of sidewalk repairs on various arterial streets in the Borough of Pierrefonds-Roxboro within the framework of the infrastructure maintenance program Minor sidewalk repairs. Authorize the payment of a sum of \$160,000, taxes included and charge this expense entirely paid by the Direction de la mobilité according to the financial information mentioned in the decision-making summary.
- **20.02** Grant contract 21-18951 to Tessier Récréo-Parc inc for the amount of its tender, to wit: \$97,444, taxes included for the supply and delivery of water games at Deauville Park in the Borough of Pierrefonds-Roxboro and authorize a maximum expense of \$117,638.05, taxes included, to wit \$112,036.24, taxes included for the contractor's contract and \$5,601.81, taxes included, for the contingencies.
- **20.03** Grant contract 21-18925 to Techsport inc. for the amount of its tender, to wit: \$635,380, taxes included, for the supply, delivery and installation of playground equipment for children aged 2 to 5, 5 to 12 and 12 to 15 years old at Deauville Park in the Borough of Pierrefonds-Roxboro and authorize a maximum expense of \$767,054.57, taxes included, to wit \$730,528.16, taxes included for the contractor's contract and \$36,526.41, taxes included, for the contingencies.

- **20.04** Grant contract SP-2021-08 to Agence de planification urbaine et régionale (APUR), for the amount of its tender, for a maximum sum of \$61,546.12, taxes included, for professional services for the elaboration of a detailed planning Specific Urbanism Program for the boulevard Saint-Charles sector in the Borough of Pierrefonds-Roxboro and authorize a total expense of \$70,778.04, taxes included, which covers the contractor's contract (\$61,546.12, taxes included) and the 15% contingencies (\$9,231.92, taxes included).
- **20.05** Cancel the tendering process for project SP-2021-12 for professional services to prepare an integrated plan to control and mitigate the risks associated with spring flooding in the Borough of Pierrefonds-Roxboro.
- **20.06** Reject all the tenders received for cleaning and televised inspection of sewer pipes including the transportation and disposal of residues for the period of September 16, 2021 to December 31, 2023 for the Borough of Pierrefonds-Roxboro, given that the expenditure for this activity is under the control of the Direction des réseaux d'eau. Given that this department is unable to guarantee the sums necessary for the granting of this contract for the year 2022 and following, the Public Works Department cannot grant contract 21-18813.
