20.01	Authorize the purchase of two tickets at a total cost of \$1,200 for the "17 <sup>th</sup> Annual Lakeshore Ball" to the benefit of the Lakeshore General Hospital Foundation and authorize some Council members to attend this event which will take place on Saturday November 11, 2017.
20.02	Grant subsidies for a total amount of \$47,567.67 to three organizations for the year 2017 with the Plan d'action 2017 de la Politique de l'enfant de Montréal. Approve the three agreements and authorize Francyne Gervais, director Culture, Sports, Leisure and Social development to sign the agreements.
20.03	Grant a subsidy in the amount of \$6,877.61 to the organization Club Optimiste de Roxboro, representing the shortfall to achieve budgetary balance in 2017. Authorize Mrs. Louise Zampini, head of division, Culture, Libraries and Social Development to sign the agreement on behalf of the Borough.
20.04	Grant an annual subsidy in the amount of \$1,700 from the 2017 operating budget to the community organization Club Roxboro 60 Plus. Authorize Mrs. Louise Zampini, head of division, Culture, Libraries and Social Development to sign the agreement on behalf of the City.
20.05	Grant a subsidy in the amount of \$10,000 to the community organization Carrefour des 6-12 ans de Pierrefonds-Est inc. for artistic activities programs intended for children of 6-12 years, from the operating budget. Authorize Mrs. Louise Zampini, head of division, Culture, Libraries Social Development, to sign the agreement on behalf of the City.

- 20.06 Authorise the use an amount of \$511,407.49, taxes included, from the price schedule unused quantities to pay the contingencies as part of the contract ST-16-06 granted to Construction Bau-Val inc. by resolution CM16 0596, for the construction of a sanitary sewer (between pumping station located at 10402, rue du Belvédère and 3<sup>e</sup> Avenue Nord), the replacement of a sanitary sewer (between 6<sup>e</sup> Avenue and 8<sup>e</sup> Avenue) and related works on boulevard Gouin Ouest in the Borough of Pierrefonds-Roxboro.
- **20.07** Acknowledge the termination of contract ST-16-31 granted to the firm Aménagements Sud-Ouest by resolution CA17 29 0045 for development work at the Anciens-Combattants park of the Marina in the Borough of Pierrefonds-Roxboro.
- 20.08 Increase the contingencies of contract SP-2015-04 by \$60, 608.18, taxes included, for the revitalization of the marina located on rue Rose in the Borough of Pierrefonds-Roxboro as part of contract granted to Cobalt, formerly called Girard Côté Dion architects, by resolution CA15 29 0221, thus bringing the contract total amount from \$402,190.60, taxes included, to \$471,798.78, taxes included.
- **20.09** Grant a subsidy in the total amount of \$15,811.34 from the 2017 operating budget to the organization Refuge pour les femmes de l'Ouest de l'île, representing municipal taxes for the year 2017 for the two buildings.
- **20.10** Grant a non-recurring subsidy of \$14,500 from the Borough surplus to On Rock Ministries inc. in order to support the 2017 operating budget. Authorize Francyne Gervais, Director, Culture, Sports, Leisure and Social development to sign the agreement on behalf of the City.
- Approve the addenda project modifying the professional services agreement between the firms Chevalier Morales architectes inc. and DMA architectes s.e.n.c.r.l. Increase the contract of these firms from \$934,944.05 to \$1,166,257.62, taxes included to adjust fees according to the works real cost and for the increased surveillance services on the construction site for the extension and redesign of the Pierrefonds library (building # 3101) located at 13 555, boulevard de Pierrefonds in the Borough of Pierrefonds-Roxboro. Authorize an additional maximum expense of \$231,313.57, taxes included.
- 20.12 Approve the addenda project modifying the professional services agreement with the firm Bouthillette Parizeau inc. Increase the contract of this firm from \$805,803.72 to \$1,033,919.03, taxes included to adjust fees according to the works real cost and for the increased surveillance services on the construction site for the extension and redesign of the Pierrefonds library (building # 3101) located at 13 555, boulevard de Pierrefonds in the Borough of Pierrefonds-Roxboro. - 40.02 Second draft By-law CA29 0040-30 modifying zoning by-law CA29 0040 in order to bring modifications, adjustments and clarifications to various articles, namely: new definition for multifamily dwelling (article 5), modification of the requirements of paragraph f of article 140.1 regarding requirements relative to a private garage or a carport attached to or integrated into a dwelling, bring clarifications in the case of a space of a length of 5 m to article 199 entitled "Dimensions of parking spaces and of circulation aisles".

- 40.03 Second draft By-law CA29 0040-31 modifying zoning by-law CA29 0040 in order to modify the C-8-486 specifications chart to: add the use category residential detached single-family "H1", add the specific permitted use 6344: landscaping and snow removal services from C5C use group, replace the existing note in order to allow a single accessory building for the specific permitted uses 536 and 6344 from C5C use group, restrict the specific permitted uses 536 and 6344 from C5C use group, include new specific provisions regarding landscaping related to uses 536 and 6344, authorize a single primary use, to wit type 536 or 6344 for an "H1" building and to add a specific provision to article 345 specifying the activity areas onsite.
