

**SYSTEMIC RACISM AND DISCRIMINATION  
2023-2024 REPORT BY THE MUNICIPAL ADMINISTRATION  
PUBLIC DISCUSSION**

The Commission sur le développement social et la diversité montréalaise and the Commission de la sécurité publique (hereinafter the joint committee) invite Montrealers to take part in a public discussion during which the city will present a progress report on its work to fight against systemic racism and discrimination.

**CONDUCT OF THE PUBLIC MEETING**

During the public meeting, the Bureau de la commissaire à la lutte au racisme et aux discriminations systémiques, along with city departments, will present a status report on the city's achievements in the fight against systemic racism and discrimination.

The report will be presented in two phases.

The following components will be presented during the public meeting held in the afternoon (1 p.m. to 4 p.m.):

- Cultural equity
- Territorial and economic equity
- Inclusive citizen participation

The following components will be presented during the public meeting held in the evening (7 p.m. to 10 p.m.):

- For an administration free of racism and discrimination
- Urban safety without profiling

The presentations will be followed by a question and comment period for members of the public (in the meeting room, then remotely), and the meeting will end with a question and comment period for joint committee members.
