## Towards a Montréal roadmap for a circular economy

The <u>Commission sur le développement économique et urbain et l'habitation</u> (committee) would like to consult Montrealers on the city's project for a **circular economy roadmap**.

As real local economic development tools, circular economy initiatives shrink the environmental footprint and contribute to the community's well-being. The proposed road map contains 13 strategic priorities in five sector value chains.

All interested parties are invited to participate in the consultation and submit an opinion. The consultation is targeted first to actors in Montréal's business ecosystem such as enterprises (industries, businesses, services, social economy enterprises, non-profit organizations, etc.), support and coaching organizations in the business community and research institutions.
